C-19 vacs - NHSE extends contracts until 31st August

NHS England has written to pharmacies currently providing the COVID-19 vaccination service to ask whether they would be willing to extend the duration of their current contract to provide the service until 31st August 2024.

Item of service fee for Covid vaccinations administered within a pharmacy or care home will be £10.04.

Anenta Pre-Acceptance Waste Audit completion

You would have recently received details from Anenta via your NHSmail account. Anenta have requested that pharmacies complete a Pre-Acceptance Waste audit, which will be valid for either 12 months or five years from the date of completion depending on the volume of waste produced.

We are working with Anenta to produce a webinar/YouTube video to assist in this: They have kindly shared a GP video they produced and we asked some contractors to review this, however it was felt to be too GP-specific and so a pharmacy resource is going to be made available.

CPPE Optimising inhaler technique – improving outcomes

Tuesday 26th March 2024 at St Helena, Myland Hall, Barncroft, Colchester, CO4 9JU 7–9pm



All healthcare professionals who come into contact with people who are using inhalers should be able to check inhaler technique and provide advice to improve the use of inhaled medicines. This workshop will develop knowledge, skills and confidence to support patients to improve their outcomes and have an impact on the quality of life for people with COPD and asthma.

The workshop considers the different types of inhaler devices available and how the delivered dose is made in each type, the breathing technique

required for each type and the potential implications of suboptimal technique. The workshop is open to pharmacists, technicians and trainee pharmacists working in all sectors of pharmacy.

Please also bear in mind that many of you will have submitted PQS respiratory domain which states "By the end of 31 March 2024, **all pharmacists working at the pharmacy on the day of the declaration**, who are providing NMS, with the appropriate inhaler technique check, must have **satisfactorily completed**, within the last four years (between 1 April 2020 and end of **31 March 2024**), the CPPE Inhaler technique for health professionals: getting it right e-learning or attended a **CPPE optimising inhaler technique: improving outcomes workshop** and passed the inhaler technique for health professionals e-assessment."
